EXPRESSION OF INTEREST (EOI) FOR TEMPORARY INSTALLATION OF CCTV CAMERAS AND VIDEO SURVEILLANCE SYSTEMS (USING VIDEO MANAGEMENT SOFTWARE) AT DIFFERENT EXAMINATION CENTRES ALL OVER THE STATE OF ODISHA.

Introduction

Board of Secondary Education (BSE), Odisha, Cuttack invites "Expression of Interest" from reputed and expert firms having experience in installation of CCTV cameras and its accessories, who have successfully provided comprehensive IP Based CCTV cameras and its accessories in major organisation of Central Govt./ State Govt./ Central Autonomous Bodies/ State Autonomous Bodies/ Central Public Undertaking/ State Public Undertaking/ Educational Institutes.

The purpose of Expression of Interest is to assess the proposed technical solutions and the capabilities of organisations who can meet the expectations of B.S.E., Odisha.

Scope of Work

Broadly the complete scope of work for the vender is as follows :-

1. It includes installation of CCTV cameras along with the requisite hardware and software for the CCTV surveillance system to connect the control room with all the mentioned locations.
2. The supplier should provide turn-key solution for the entire site.
3. The system should facilitate viewing of live and recorded videos and controlling of all cameras by the authorised users.
4. All the cameras installed under this project shall be sending uninterrupted live video stream to the control room.
5. The installation will be for a period of maximum 15 days between 3rd week of February to 1st week of March-2019.
6. Installation will be at approximately 3000 examination centres located through out the state.

Expression of Interest Documents should cover the following :-

Technical Bid (in separate envelope)

1. Core business areas of operation, number of years in the business, ownership and organisational structure of the company.
2. Client reference and brief details of the similar projects undertaken if any.
3. Audited financial statement for the last 3 years showing financial capability.
4. Schematic diagram of the proposed system.
5. Flow chart for control applications.
6. Approach paper for the proposed project.
7. Any other relevant information.

Financial Bid (in separate envelope)

1. Approximate cost of the project, with a valuation centre, with 8 cameras as a unit.

Evaluation of Expression of Interest Responses

Based on the evaluation of submitted documents, Board of Secondary Education, Odisha will call the bidders for Demo/ Presentation.

The presentation should cover :-

1. Understanding of scope of work.
2. Planned Technologies/ Solutions.
3. Strategy and planning for the execution of project.
4. Live demo of proposed Solutions/ Devices.
5. Timeline for the Execution of Project.
6. Past experience of the bidder and reference.

Other Requirements and Terms & Conditions

1. The Expression of Interest shall be submitted by the interested bidders at the office of the Board of Secondary Education, Odisha, (in the chamber of the Secretary) Cuttack, Bajrakabati Road – 753001; on or before 03.00 pm on 14/11/2018 in a sealed cover (separately for Technical & Financial Bid) addressing to the Secretary, B.S.E., Odisha, Cuttack. The sealed Expression of

Interest documents will be opened on 16/11/2018. The participating firms or their representatives are at liberty to attend the proceedings of opening of the Expression of Interest.

2. After opening the technical bid for Expression of Interest, the selected firms shall be required to give live demonstration/ presentation of the proposed project at a short notice.
