



**BOARD OF SECONDARY EDUCATION, ODISHA, CUTTACK
NOTIFICATION**

In pursuance of Chapter-IX of the Board's Regulations and Resolution No-18000/SME/ IX-SME-SCH-12/2019 of the Govt. of Odisha, Department of School & Mass Education, applications in the prescribed form are invited from Secondary Schools of Odisha for **Renewal Recognition** for the Session, 2019-20. (for which application was not invited during the said session) and **Fresh/ Renewal Recognition** for the Session, 2021-22.

1. Following category of schools shall be eligible to apply for renewal recognition for the session, 2019-2020.
 - (a) The schools who have been granted fresh recognition for 2018-19 are eligible to apply.
 - (b) The schools who have not been granted renewal of recognition for 2019-2020 shall apply for the same.
 - (c) The schools applying for renewal of recognition for 2021-22 shall have to apply for getting renewal of recognition for 2019-20 incase they were eligible during that session. Without the grant of renewal of recognition for 2019-20, their application for grant of renewal of recognition for 2021-22 shall not be considered.
2. Following category of schools shall be eligible to apply for grant of Recognition by the B.S.E., Odisha.
 - (a) The schools who have been issued NOC by the Director, Secondary Education, Odisha with the clearance of the High Power Committee formed by the Govt.
 - (b) The Schools who have been granted recognition of class- VIII by the Director, Secondary Education, Odisha Bhubaneswar will be eligible to apply for Fresh recognition of Class- IX, X for the year 2021-22.
 - (c) The schools who have got Recognition for Class-IX by the High Power Committee of the Govt., for the year 2020-21 will be eligible to apply for fresh Recognition of Class-X for the year 2021-22.
3. The government secondary schools are deemed to have been Recognised and hence, they should not apply for grant of Recognition.

4. Fees for Affiliation:-

5. Remittance of Fees:-

The fees as above shall be deposited by the intending schools in the following SBI Account through pay-in-slip of Board at various branches of the State Bank of India. Remittance of fees in any other manner shall not be entertained. They must attach the copy of the pay-in-slip with the application form.

5. The applicant schools shall submit the filled in application forms in duplicate along with all the enclosures to the District Education Officers on or before 15/12/2021. The District Education Officers shall send to the concerned Zonal Offices of the Board on or before 25/12/2021. The zonal offices shall submit all applications received from concerned DEOs in the Head Office on or before 01/01/2022.
6. The application form for grant of Recognition and Pay-in slip shall be made available in the website www.bseodisha.ac.in from the date of issue of this notification.
