VOCATIONAL EDUCATION FOR CLASS-X (LEVEL-II)

No:-100(syllabus)/ Date:-02.05.2018

In pursuance to Letter **No-826/VE, dtd-03.04.2018** of the Joint Director, OMSM,RMSA the Vocational Education Course under RMSA at Secondary School Level in Trades i.e. **1.IT & ITES, 2.Travel & Tourism , 3.Retail Marketing** will continue as such in Class-X (Level-II) for the **Academic session-2018-19**. Further, **4.BFS (Business Correspondence) , 5.Beauty & Wellness , 6. Health Care in Class-X (Level-II)** will be introduced newly for the **Academic Session-2018-19** as compulsory subject in 208(old) & 106(new) selected Schools as notified in **Notification No-458(Syllabus) dated-19.07.2017** .

The above subjects shall be the alternative of the existing 3rd language subjects . The students will Opt. either one of the Third Languages or Vocational subject as per their choice. The period of distribution shall be as that of Third Language Subjects i.e. 04 period per week so as to complete 200 hours of course of Level-2.

The course curriculum shall be at par with the curriculum offered by PSSCIVE, Bhopal.

The Syllabus , Courses of Studies and Student's Hand Book (translated in Odia) and other relevant documents will be provided through RMSA shortly.
