INSTRUCTION TO TENDERER

1. Tenderers are required to fill up the Technical Bid & keep it in one envelop along with other requisites & super scribe it as “**Technical Bid**”. Similarly Financial Bid should be kept in another envelop & super scribe it as “**Financial Bid**”. Both the sealed envelopes shall be kept in another envelop & super scribe as “**Tender for polymer Tamper-evident-envelops**, Tender call Notice No- _____ dt _____
2. Tenderers are requested to submit EMD of Rs-10,000/- (Rupees Ten thousand) only in shape of Bank Draft in favour of Secretary, Board of Secondary Education, Cuttack payable at Cuttack along with the tender.
3. Tenderers are to submit nos. of samples of Polymer Tamper Evident Envelops required sizes and specifications along with tender paper.
4. Tenderers are required to submit photocopies (one each) of PAN Card, I.T. & GST Clearance Certificate, obtained from the appropriate authority in original along with the tender paper. The original Certificates of the above documents would be submitted on the date of opening of Tender Papers.
5. If the Tender Paper has been downloaded from the Website the cost of the Tender Paper Rs-560/-(Rupees Five hundred and sixty) only shall be submitted along with the tender in shape of Bank Draft drawn in favour of Secretary, Board of Secondary Education, Odisha, Cuttack payable at Cuttack.



TERMS AND CONDITIONS

1. Tenderers are required to fill up the Technical Bid & keep it in one envelop along with other requisites & super scribe it as “**Technical Bid**”. Similarly Financial Bid should be kept in another envelop & super scribe it as “**Financial Bid**”. Both the sealed envelopes shall be kept in another envelop & super scribe as “**Tender for polymer Tamper-evident-envelops**, Tender call Notice No- dt-
2. The tenderer shall deposit E.M.D. of Rs-10,000/- (Rupees Ten thousand) only in shape of Bank Draft drawn on any Nationalised Bank in favour of Secretary, Board of Secondary Education, Odisha, Cuttack payable at Cuttack. Tender without accompanying E.M.D. shall be rejected.
3. The E.M.D. of unsuccessful tenderer(s) will be refunded soon after finalization of tender. No interest shall be paid on EMD deposit.
4. All columns of Technical Bid and Financial Bid must be filled in properly.
5. The Tender should accompany samples of specifications and quality as per Annexure-A.
6. Tender without samples and other requisites such as photocopy of Reg. No., PAN Card, up to date I.T. & GST Clearance Certificates shall be rejected.
7. The rate should be quoted inclusive of all taxes / levies.
8. Over writing, insertion, addition, alteration and erasing on Tender Paper should be avoided. This may cause disqualification. Corrections if any on tender paper, in either or the bids should be duly attested by the tenderer.
9. Rate for supply of each item should be quoted per thousand only and should be written both in figures and words.
10. The Financial Bids of all the tenderers whose Technical Bids are found in order and are qualified only will be opened.
11. L-I will not be the only criteria for award of tender. Experience / expertise in the field, credibility of the firm, quality and suitability of the items to match the requirement will be taken in to consideration for qualification of Financial Bid.
12. The successful tenderer shall have to execute an agreement & deposit security money amounting to Rs- 30,000/- (Rupees Thirty thousand) only in shape of Bank Draft drawn on any Nationalised Bank in favour of the Secretary, Board of Secondary Education, Odisha, Cuttack payable at Cuttack within 07(seven) days from the date of award of tender .
13. The tenderers shall produce the Original documents related to Financial Bid on the date of opening of tenders.

14. If the tenderer fail to execute the agreement and does not deposit security money within the stipulated date, the EMD will be forfeited and award of tender shall be cancelled and next eligible tender shall be awarded the work.
15. The delivery of envelopes shall be made strictly as per the date specified in the supply order.
16. Board shall have the power to refuse / accept any envelope, in the event of supply not matching the sample submitted along with tender both in quality and size.
17. Payment shall be made after complete delivery of items.
18. TDS (I.T. & GST) shall be deducted at the time of payment of bill.
19. If the tenderer fails to deliver the materials in time as specified in the work order or supplies inferior /sub-standard quality or goods or violates any of the conditions of tender/work order. Board reserves the right to forfeit the security deposit and take other action as deemed proper in the event.
20. The tenders shall be opened in presence of the tenders or their authorized representatives if any, otherwise the tender of the absentee shall be rejected.
21. President, Board of Secondary Education, Odisha, Cuttack shall have the power to amend any of the terms & conditions of the tender.
22. After due formalities stated above, final order shall be placed with the firm for procurement of Polymer Tamper Evident Envelops.
23. In the event of any dispute arising in execution of the tender, the decision of the President, Board of Secondary Education, Odisha shall be final & binding on the Tenderer.
24. Any dispute related to this tender and arising out of terms and conditions thereof, will be subject to jurisdiction of Court at Cuttack only.
