**INSTRUCTION TO TENDERER**

1. Tenderers are required to fill up the Technical Bid & keep it in one envelop along with other requisites & super scribe it as "**Technical Bid**". Similarly Financial Bid should be kept in another envelop along with required documents & super scribe it as "**Financial Bid**". Both the sealed envelopes shall be kept in another envelop & super scribe it as "**Tender for Transportation of Confidential Materials**", Tender call Notice No- dt-

Tenderers are requested to submit EMD of Rs.30,000/- (Rupees thirty thousand) only in shape of Bank Draft drawn in favour of Secretary, Board of Secondary Education, Odisha, Cuttack, payable at Cuttack along with the tender.

2. Transportation and delivery of confidential material to different Nodal Centres across the state may continue for at least for 5 consecutive days or more. In case of some Examination tenderer must have to provide 10 numbers of 6 wheeler close container of different capacity and in some cases 4 wheelers container if required per day till completion of the work.
3. Tenderers are required to submit one true copy of PAN Card and I.T. Clearance Certificate, GST Clearance Certificate/ receipt of deposit of last qtr, obtained from the appropriate authority along with the tender.
4. If the Tender Paper are to be downloaded from the Website, the cost of the Tender Paper Rs-7,080/- (6,000/- + 18% GST) (Rupees Seven thousand eighty) only shall be submitted along with the tender in shape of Bank Draft drawn in favour of Secretary, Board of Secondary Education, Odisha, Cuttack, payable at Cuttack.
5. The closed Containers must be in good running condition with up to date Tax Clearance and fitness certificates, Insurance and all Odisha permit. (A undersign regarding this to be given)
6. The driver of each vehicle must have valid Driving License and good track record of not intoxicated with alcohol etc. (A undersign regarding this to be given)
7. The authority reserves the right to transport the confidential materials by other means of conveyance for timely completion of the work at the time of exigency.
8. The bills are to be submitted after completion of the assignment for payment.
9. A letter of confirmation in this regard should be sent within 3 days from the date of issue of work order.
10. The President shall have the right to reject any tender without assigning any reason thereof.

## TERMS AND CONDITIONS

1. Tenderers are required to fill up the Technical Bid & keep it in one envelop along with other requisites & super scribe it as "**Technical Bid**". Similarly Financial Bid along with required documents should be kept in another envelop & super scribe it as "**Financial Bid**". Both the sealed envelopes shall be kept in another envelop & super scribe as "**Tender for transportation of Confidential materials**", Tender call Notice No- dt-
2. The tenderer shall deposit E.M.D. of Rs-30,000/- (Rupees twenty thousand) only in shape of Bank Draft drawn on any Nationalised Bank in favour of Secretary, Board of Secondary Education, Odisha, Cuttack payable at Cuttack. Tender without accompanying E.M.D. shall be rejected.
3. The E.M.D. of unsuccessful tenderer(s) will be refunded soon after finalization of tender. No interest shall be paid on EMD deposit.
4. All columns of Technical Bid and Financial Bid must be filled in properly.
5. Tender without list of vehicle Number and other requisites such as copy of PAN Card, up to date I.T. Clearance Certificate & GST Clearance Certificate/ deposit receipt of last qtr. shall be rejected.
6. The rate should be quoted exclusive of all taxes / levies but including cost of fuel, driver and Toll Gate charges etc.
7. Over writing, insertion, addition, alteration and erasing on Tender Paper should be avoided. This may cause disqualification. Corrections if any on tender paper, in either Technical or Financial bids should be duly attested by the tenderer.
8. Rate for transportation of each category of vehicle for to & fro journey should be quoted per Km. only and should be written both in figures and words.
9. The Financial Bids of all the tenderers whose Technical Bids are found in order and are qualified, only will be opened.
10. For award of tender L-I will not be the only criteria but experience / expertise in the field, credibility of the firm, for transportation of confidential materials will be taken in to consideration for qualification of Financial Bid.
11. The successful tenderer shall have to execute an agreement & deposit security money amounting to **Rs.60,000/- (Rupees Sixty thousand)** only in shape of Bank Draft drawn on any Nationalised Bank in favour of the Secretary, Board of Secondary Education, Odisha, Cuttack, payable at Cuttack within 03 ( three) days from the date of award of tender .
12. The tenderer must have completed successfully at least one assignment in any Govt./PSU/Reported private agency within last 02 years. Appropriate work assignment assigned orders from any Central / State / Reputed private agency to be attached.
13. If the tenderer fail to execute the agreement and does not deposit security money within the stipulated date, the EMD will be forfeited and award of tender shall be cancelled and next eligible tenderer shall be awarded with the work
14. After due formalities stated above, final order shall be placed with the Transport Agency along with the process of execution of assignment.

15. The transportation of confidential material would be made as per specified date & time, which would be intimated later on along with category of closed containers required on each date of assignment.
16. Board shall have the power to refuse / accept any tender without assigning any reason thereof.
17. Payment shall be made after the transportation of confidential materials is over on submission of bill along with other relevant documents as specified in the work order failing which the bills cannot be processed.
18. TDS shall be deducted at the time of payment of bill.
19. If the tenderer fails to deliver the confidential materials within time as specified in the work order or fails to provide the closed containers as required the authority of the Board reserves the right to forfeit the security deposit/EMD and take other action as deemed proper.
20. The tenders shall be opened in presence of the tenders or their authorized representatives if any, present on the schedule date/time/venue.
21. The closed containers must be in good running condition with up to date Tax Clearance receipts, Fitness Certificates, Insurance and all Odisha permit.
22. The driver of each vehicle must have valid Driving License and good track record of not intoxicated with alcohol etc.
23. The tenderer shall bear all risks, responsibility and also extra cost in case of break down or damage of any part of container and should ensure timely delivery of confidential materials at the destination without fail.
24. President, Board of Secondary Education, Odisha, Cuttack shall have the power to amend any of the terms & conditions of the tender in case of exigency.
25. Detention charges may be consider if the vehicle detrained with a genuine case/unavoidable situation/both basing on the report of authorised persons from BSE/destination point. The Detention charges to be calculated based on Boards norm.
26. In the event of any dispute arising in execution of the tender, the decision of the President, Board of Secondary Education, Odisha shall be final & binding on the Tenderer.
27. Any dispute related to this tender and arising out of terms and conditions thereof, will be subject to jurisdiction of Court at Cuttack only.
