In pursuance of Chapter-IX of the Board's Regulations and letter No.-18000/SME/IX-SMESCH-12/0019 of the Govt of Odisha, Department of School & Mass Education, applications in the prescribed forms are invited for Fresh/ Renewal/RUFO Recognition for the session 2026-27 simultaneously through online mode only.

- The following category of schools shall be eligible to apply for Fresh Recognition for the session 2026-27,
 - The schools who have been granted Recognition of Class-VIII prior 2013 by the Director, Secondary Education, Odisha, Bhubaneswar will be eligible to apply for Fresh Recognition of Class-IX/X/IX & X for the year 2026-27.
 - The schools who have been accorded Recognition for Class-IX by the High-Power Committee of the Govt. during the year 2023-24/2024-25/2025-26 will be eligible to apply for Fresh Recognition of Class-X for the year 2026-27 respectively.
- The following category of schools shall be eligible to apply for Renewal of Recognition for 2026-27.
 - Schools which have been accorded Fresh Recognition for the session 2023-24/2024-25/2025-26 shall apply for Renewal of Recognition 2026-27 simultaneously.
 - Schools other than Govt. schools which have not been accorded Recognition until Further Orders and whose Recognition is being renewed every year shall apply for Renewal of Recognition 2026-27 simultaneously.
- The following category of schools shall be eligible to apply for RUFO.
 - Schools which have been accorded with Fresh Recognition on or before 2023-24.
 - Schools whose recognition is being renewed every year.
- The Government Secondary schools are deemed to have been recognized and hence, they should not apply for Grant of Recognition.
- Fees for Recognition:-

- The applicant schools shall submit the filled in ONLINE application forms for Fresh/Renewal/RUFO of Recognition from 10/08/2026 to 30/08/2026 for the sessions 2026-27. They have to submit the online application forms with Two Sets of Hard Copies of the requisite documents before the concerned District Education Officers in stipulated time period in case of applying Fresh/RUFO category only.
- The District Education Officers shall forward the online application forms for Fresh/Renewal/RUFO to the Dy. Secretaries of Zonal Offices concerned after due scrutiny and verification on or before 30/09/2026 along with hard copies of the documents for Fresh/RUFO category only.
- The Deputy Secretaries of zonal offices shall submit all applications received for different category of recognition to the Head Office on or before 20.10.2026.
